PayMe 2023 Consumption Voucher Scheme 2nd Instalment Registration Campaign Terms and Conditions:

When is the Campaign?

1. Unless otherwise specified, the promotional period for the PayMe 2023 Consumption Voucher Scheme 2nd Instalment Registration campaign ("Campaign") is from 5 June 2023 to 15 July 2023 ("Promotion Period").

Who can enjoy the Campaign?

- 2. The Campaign is offered exclusively to PayMe customers with the below criteria:
 - a) who have registered and successfully received their 2023 Consumption Voucher Scheme 1st instalment consumption vouchers with PayMe (each as "Existing Registrant"); or
 - b) who have switched to receive their 2023 Consumption Voucher Scheme 2nd Instalment consumption vouchers with PayMe (each as "**New Registrant**");

(both as "Eligible User").

PayMe Rewards

I. Existing Registrants Rewards

- 3. Subject to these terms and conditions, Existing Registrants will be entitled to six (6) PayMe discount vouchers (each individually a "Voucher" and collectively the "Vouchers") with aggregate value of HKD 1,150 in their respective PayMe wallets. The Vouchers will be pre-issued to the Existing Registrants' PayMe wallets on 7 June 2023 (as the "Issue Date"), in the following manner:
 - a) one (1) HKD 500 Voucher;

- 4. In case of an Existing Registrant switching to receive their 2023 Consumption Voucher Scheme 2nd instalment consumption vouchers with Stored Value Facilities (SVF) other than PayMe after the Issue Date, the Bank reserves the right to forfeit and withdraw the pre-issued Vouchers from the Existing Registrant's PayMe wallet without prior notice.

II. New Registrant Rewards

5. Subject to these terms and conditions, New Registrants will be entitled to seven (7) Vouchers with an aggregate value of HKD 1,300 in their respective PayMe wallets. The Vouchers will be issued within 3 working days of receiving confirmation of such registration from the Government, in the following manner:

- a) one (1) HKD 500 Voucher;
- b) one (1) HKD 250 Voucher;
- c) three (3) HKD 150 Vouchers; and
- d) two (2) HKD 50 Vouchers.
- 6. The Vouchers will be issued to the Eligible Users' PayMe wallets pursuant to these terms and conditions, provided that:
 - a) the Voucher falls within the quota of the set of Vouchers to be given away during the Campaign on a first- come- first- served basis; and
 - b) the Eligible User's PayMe wallet is not suspended or terminated on the relevant issue date of the Vouchers.
- 7. PayMe may increase the number of Vouchers it issues during the Promotion Period, at its sole discretion.
- 8. The Vouchers will be available for redemption from the effective date stated on the relevant Vouchers. The Vouchers must be used within the redemption period and expire automatically on the expiry date stated on the respective Voucher (the "Expiry Date") if unused and is subject to these terms and conditions.

11. A Voucher cannot be transferred to another user or exchanged for cash.

For the avoidance of doubt, where a user holds multiple Vouchers that may be applied towards an Eligible Transaction, the Voucher will automatically apply by highest discount value first, then by earliest expiry date. In case of a Voucher with the same discount value and expiry date, then the Voucher credited to the PayMe wallet first will apply.
