

## **PayMe PayStreak Rewards Terms and Conditions:**

### **When is the promotion?**

1. Unless otherwise specified, the PayMe PayStreak Rewards (“**Promotion**”) will be conducted in 3 phases as below:
  - a) Phase 1: 2 June – 28 June 2023
  - b) Phase 2: 1 July – 30 July 2023
  - c) Phase 3: 1 August – 30 August 2023(each phase is a “**Promotion Period**”).

### **Who can participate in the promotion?**

2. The Promotion is offered to all PayMe users to participate during the Promotion Period (each an “**Eligible User**”).

### **PayMe PayStreak Mission**

3. During the Promotion Period, Eligible Users must perform a successful transaction of HKD 80 or above at a PayMe merchant to its PayMe for Business wallet to earn a PayStreak (“**Criteria**”).

Upon meeting the Criteria, Eligible Users will be entitled to the following rewards in the respective PayMe wallet for each phase of the Promotion Period:

- For 4 to 5 PayStreaks earned, Eligible Users can get an HKD 6 PayMe discount voucher; or
- For 6 or more PayStreaks earned, Eligible Users can get an HKD 10 PayMe discount voucher

(each individually a “**Voucher**” and collectively the “**Vouchers**”).

4. Each Eligible User will be entitled to a maximum of 1 Voucher for each phase.
5. A PayStreak will be voided if:
  - a) the Eligible User or PayMe merchant initiated a full refund in respect of the transaction described in clause 3 above during or after the Promotion Period; or
  - b) the Eligible User made a transaction to a merchant's personal PayMe wallet. Users must confirm with the merchant on completing the transaction that the transaction was made to the merchant's PayMe for Business wallet.
6. The Voucher will be issued to the Eligible User’s PayMe wallet within 14 days after each phase of Promotion Period provided that:

- a) the Voucher falls within the quota of Vouchers set to be given away during the Promotion on a first- come- first- served basis;
- b) each Eligible User does not receive more than a total of three (3) Vouchers from this Promotion; and
- c) the Eligible User's PayMe wallet is not suspended or terminated on the respective Voucher.

For the avoidance of doubt, the Criteria must be taken to be met at the point in time in which the Voucher is to be issued.

(an "**Eligible Transaction**")

For the avoidance of doubt, where an Eligible User holds multiple vouchers that may be applied towards an Eligible Transaction, the Voucher that was credited/issued to the PayMe respective wallet first and with the earliest expiry date will be the Voucher that is automatically applied on an Eligible Transaction.
- 12. In case of a refund (full or partial) initiated by a customer or merchant after the transaction at which a Voucher is consumed, the Bank retains the right to withdraw the Voucher or debit the amount credited to a PayMe wallet from the Voucher.

## **PayMe PayStreak Rewards Terms and Conditions:**

### **Who can participate in the promotion?**

8. The Promotion is offered to all PayMe users to participate during the Promotion Period (each an "**Eligible User**").

### **PayMe PayStreak Mission**

9. During the Promotion Period, Eligible Users must perform a successful transaction of HKD 30 or above at a PayMe merchant to its PayMe for Business wallet to earn a PayStreak ("**Criteria**"). Upon meeting the Criteria, for every 4 PayStreaks earned, Eligible Users can get an HKD 3 PayMe discount voucher (each a "**Voucher**") in the respective PayMe wallet during the Promotion Period.
10. During each month of the Promotion Period, each Eligible User will be entitled to a maximum of 4 Vouchers.
11. A PayStreak will be voided if:
  - a) the Eligible User or PayMe merchant initiated a full refund in respect of the transaction described in clause 3 above during or after the Promotion Period; or
  - b) the Eligible User made a transaction to a merchant's personal PayMe wallet. Users must confirm with the merchant on completing the transaction that the transaction was made to the merchant's PayMe for Business wallet.
